

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Bungee America Holdings, INC.; Bungee America, LLC.; Saunders Mine, LLC., their agents, owners, officers, volunteers, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "BBS "), I hereby agree to release, indemnify, and discharge BBS, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in bungee jumping and guided hiking activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: rugged terrain; weather conditions; water hazards; accidental drowning; the negligence of other participants or myself; slips and falls; possibility of falling rocks; possibility of drowning when crossing river(s); falls from significant heights; accidents during strap in and dismount; hazards of being struck by the equipment; my own physical condition; contact with wild life animals or insects; injuries including, rope burn, sprains, strains, broken bones, fractures, scrapes, bruises and cuts, dislocations, pinched fingers and serious injuries to the head, back, or neck which can cause paralysis, or even death; transmissible pathogen or disease; equipment failure; my own physical condition, and the physical exertion associated with this activity.

Furthermore, BBS personnel have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless BBS from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of BBS 's equipment or facilities, **including any such claims which allege negligent acts or omissions of BBS.**
4. Should BBS or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against BBS I agree to do so solely in the state of California, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.
7. The undersigned waives the protection afforded by any statute or law in jurisdiction whose purpose, substance, cause and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing this release. This means, in part, that the undersigned is releasing unknown future claims and specifically waives the provisions of California Civil Code Section 1542 which provides: A general release does not extend to claims that the creditor or releasing party does not know or suspect exist in his or her favor at the time of the executing the release and that, if know by him or her, would have materially affected his or her settlement with the debtor or released party.
8. I hereby give BBS the irrevocable right to use my name, picture, photograph, portraits, visual likeness, or voice in all forms of media in all manners, including photo, film, audio and video representations, for non-profit, public purposes, and I hereby waive any right to inspect or approve the finished product that may be created in connection therewith.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against BBS on the basis of any claim from which I have released them herein. I also agree that this document is valid for subsequent visits and participation at BBS.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
