I, the above named person, in consideration of the services to be provided by Bungee America and/or any affiliated companies, and the rate charged for these services, hereby acknowledge, agree and covenant with Bungee America and/or any affiliated companies, its officers, owners and employees and all other persons or entities acting in any capacity on their behalf, (hereinafter collectively referred to as "BABJ"), do hereby voluntarily release, indemnify and discharge BABJ on behalf of myself, my spouse, my children, my parents, my heirs, personal representatives and estate as follows:

I further certify that I am not suffering from or under treatment for any physical, emotional or psychological infirmity or chronic illness including but not limited to; cardiac or pulmonary condition or disease, high blood pressure, fainting spells, convulsions, epilepsy, neurological disorders, back or neck problems, history of aneurysm or psychological disorders or mental illness, pregnancy or any other condition which could be exacerbated by my participation.

ACKNOWLEDGMENT OF RISK

I fully understand the activity that I am about to voluntarily engage in bears certain risks. I understand BABJ is not responsible for my personal property, automobile or its contents while parked in the Angeles National Forest.

I understand that BABJ does not provide a guiding service through the Angeles National Forest and it is my personal responsibility to hike the trail between the parking lot and the Bridge to Nowhere. I am aware that this hike bears certain risks including but not limited to:

- Poison oak, snake, animal or insect bites.
- Cliffs, loose or falling rock.
- Ten or more crossings of the East Fork of the San Gabriel River.

I acknowledge that my participation entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Among these risks are the following:

1) The nature of the activity of bungee jumping itself. The act of bungee jumping and the instructions provided are potentially hazardous. These hazards include but are not limited to the following:

- A. Loss of or damage to personal property.
- B. Injury or fatality due to any failure of the equipment or procedures.
- C. Collision with obstacles on the ground or in the air.
- D. Falling while aboard the Bridge or jump platform.
- E. Contact with the bungee cords can cause injuries such as, but not limited to abrasions, bruises, cuts and broken or dislocated limbs.

2) The acts, omissions or neglect in any degree of BABJ.

3) Latent or apparent defects in, or the condition of, any and all equipment or property provided by BABJ, including bungee cords, harnesses, attachment rigging, bridge, jump platform, roads, trails, parking lots, buildings and any accidents connected with their use.

4) The acts of other participants in this activity, employees and agents of BABJ.

5) My own physical condition, or my own acts or omissions.

6) In the event of an accident, any first aid emergency treatment or other services rendered by BABJ,

Furthermore, Bungee America and/or any affiliated companies, employees have difficult jobs to perform. They seek safety, but are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and equipment being used might malfunction.

I understand the above list is not complete or exhaustive, and that other risks, known or unknown, identified or unidentified, may also result in injury, death, illness, disease (physical or mental) or damage to property. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of these risks.

ACCEPTANCE OF RISK AND RESPONSIBILITY

Being aware that this activity entails risk of injury or death, I agree, covenant and promise to accept and assume all responsibility and risk for injury death, illness or disease (both physical and mental) or damage to my property arising from my participation in this activity. Injuries might include such serious injuries as to cause severe disability, paralysis, pain, suffering and death. My participation in this activity is purely voluntary, no one is forcing or coercing me to participate, and I elect to participate of my own free will in spite of the potential risk to myself and others.

FILMING, PHOTOGRAPHIC & MEDIA RELEASE

In consideration of being permitted to participate in this activity, I grant BABJ the irrevocable right and permission to video or photograph me in connection with BABJ and use the recordings for all purposes, including advertising and promotion. I understand and acknowledge all media is the exclusive property of, and may be used by BABJ in any manner, whether through internet, television, radio or any other medium now known or hereafter devised in perpetuity. I agree that I am not entitled to any compensation for my willingness to consent to the above agreement.

RELEASE, INDEMNIFICATION & DISCHARGE

I, the above named person, hereby voluntarily release, indemnify, hold harmless and forever discharge Bungee America and/or any affiliated companies, its officers, owners, agents or employees, volunteers, participants and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "BABJ"), from any and all liability, claims, demands, actions or right of action, which are related to, arise out of, or are in any way connected with my participation in this activity, including specifically but not limited to the negligence or omission of BABJ, of any and all injury, death, illness or disease (both physical or mental) and damage to my property.

I, the above named person, further agree, promise and covenant not to sue or otherwise maintain or assert any claim against BABJ for any such injury, death, illness or disease (both physical or mental) or damage that may result from my voluntary participation in this activity.

Should BABJ or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold harmless for all such fees and costs.

I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

REFUND & CANCELLATION POLICY

All payments (less \$20.00 per person cancellation fee) are refundable until 14 days prior to jump date. Cancellation fee is non-refundable.

You may reschedule ONLY if you provide 72 hours advance notice.

All rescheduled reservations must be used within 90 days of the original date you scheduled to jump. You may ONLY reschedule one time.

Jump Packages are fully transferable to another person should you find your schedule does not accommodate rescheduling.

DID NOT JUMP (DNJ) POLICY

This agreement is an opportunity to bungee jump. I certify that significant services must be performed by BABJ to process and prepare a participant prior to their opportunity to bungee jump. I understand that NO rain checks, NO refunds will be given for participants who are unable or choose not to use their bungee jumping opportunity for any reason.

ACKNOWLEDGMENT OF EFFECT OF THIS AGREEMENT

I understand and acknowledge that by signing this document, I have voluntarily given up certain legal rights and/or possible claims which I might otherwise assert or maintain against BABJ, including specifically but not limited to my rights arising from or claims for the acts or omissions, negligence in any degree, of BABJ.

In the event that I file a lawsuit against BABJ, I agree to do so solely in the state of California, and I further agree that the substantive law of California shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.
